SOUTHWEST FLORIDA INTERGROUP MINUTES, JUNE 5, 2021

Roz, chair, was not present. Margie, vice-chair, called the meeting to order at 10:36 a.m. with the Serenity Prayer.

Agenda - The existing agenda, with New Business additions, was accepted by acclamation.

May minutes - Gil made a couple of tweaks to correct typing mistakes in previously amended minutes. Maxine made a motion to accept the May minutes; Jill seconded the motion, and they were passed unanimously. Gil said he would e-mail them to Jill to post on the website

CONCEPT OF SERVICE - Pat and Margie shared the reading of the Sixth Concept of Service in its entirety.

COMMITTEE REPORTS

Chair - Roz was not present but sent notes, as reported below.

Vice-Chair - Margie noted that there will be no July meeting, as stipulated in our bylaws, and reported she will not be available to attend the August 7 Intergroup meeting.

Recording Secretary - Gil had no report.

Treasurer - Maxine announced that, after seven years in her position, she will leave her treasurer's position after the August 7 meeting. She notes that she will help the new treasurer with the needed changes.

As for the report itself, Maxine said our beginning balance was \$2,702.08 as of April 1 (since we had no treasurer's report in May, Maxine combined the past two months). During the two months, the Intergroup received nearly \$700 in donations from seven meetings in our Intergroup, and expended \$150 to reimburse our Region 8 rep for money laid out. Including the money in our cd fund and donations made for IDEA Day, minus \$60 for cd purchases), the ending balance is \$3,231.61. After discussion and voting, Maxine was asked to send a donations of \$750 to WSO, \$250 to Region 8 and \$100 to the Riverside Church, leaving the Intergroup with approximately \$1,500 (\$500)

of which is a prudent reserve kept in our Wells Fargo checking account to cover the bank's required minimum balance).

Website - Jill, website chair, reported she has received two articles on the website that share experience, strength and hope. She said everyone is welcome to send articles to the website, which she will post.

Audio Library - No report. Maxine will contact Debbie J regarding a box of OA talks on cd that Maxine has at her home.

Region 8 - Roz sent an e-mail reporting that her committee has sent out information to all chairs to assess interest in changing meetings to hybrid, which is now an official name, voted at WSBC, with a description.

Twelfth Step Within - No report. Position is vacant. Margie has suggested and the group has agreed that we will put Twelfth Step Within Day (Sunday, December 12, 2021) workshop on the agenda for the September 4, 2021 Intergroup meeting.
