

Minutes Intergroup Meeting

March 1, 2025

Meeting was called to order at 10:36 am. Jodi was to chair but she was absent so we did the best that we could.

Treasurer's Report delivered by Alice H. approved (Bonita K's \$209.92 was not taken out of the \$ 500. allowed for this project. It was deducted from overall holdings.)

Summary of Treasurer's Report: We started February with \$5,789.50 in our LMCU checking and savings accounts. We received four 7th Tradition donation checks in February, totaling income of \$320.

February expenses were rental of our storage unit for one month for \$55.19 (versus what we previously paid of \$66.46 and \$38.79/month) and reimbursement of PIPO expenses of \$209.92 paid by Bonita for a table, canopy, tablecloths, and wagon. Total expenses for February were \$265.11.

At the end of February the total amount of our savings and checking accounts at LMCU was \$5,844.39 after adding the income and subtracting the expenses from the balance at the beginning of February.

As a reminder to everyone, the total amount of our funds is allocated to four areas: \$500 for PIPO/Literature Fund, \$1,000 for Retreat Scholarship Fund, \$200 for Prudent Reserve, and \$3,000 for WSO/Region 8 Rep expenses. These four areas total \$4,700. The remaining balance in our LMCU account for payment of other expenses is \$1,144.39.
